### Re-inspection fee for initial inspection failure:

First re-inspection, \$35.00

Second re-inspection, \$50.00

Third and subsequent re-inspections, \$75.00 per re-inspection until inspection is passed

Fees are to be assessed and collected prior to the issuance of final Certificate of Occupancy

No final Certificate of Occupancy shall be issued for a project with outstanding fees.

Permit Fee, \$75.00.

Up to the first ten (10) squares, \$12.00 plus \$6.00 for each additional 1,000 per roofing square.

### **Swimming Pools:**

Permit Fee, \$75.00 plus 12¢ per square foot.

### **Gasoline Storage Tanks/Pumps:**

Underground storage tanks: \$50.00.

Pumps and dispensing equipment: \$50.00 per pump.

### **Demolitions:**

Demolition Permit Fee, \$35.00 for the first 1,000 Sq. ft.

Residential: \$5.00 for each additional 1,000 sq. ft.

Selective interior demolition fee, \$50.00

Commercial: \$10.00 for each additional 1,000 sq. ft.

Removal of a building or structure from one lot to another, \$90.00.
