#### **INCOME ELIGIBILTY**

To qualify for the program, recipients must meet CDBG income eligibility criteria, which are determined by annual income and household size. See the Income Guidelines Chart below:

# WHAT DOES THE PROGRAM COVER?

- Paint, Remove/Replace Doors, Windows Thresholds, Stair Railings
- Moisture/Mold Remediation, Flooring, Plumbing, Ventilation and Asthma Interventions, Roof and Wall Repair
- Appliance Updating, Electrical Safety, GCFI and Wiring Upgrades
- Rodent, Bed Bug, Pest Treatments
- Minimal Rehab to Protect Lead Paint From Further Deterioration
- and more...

#### WHO IS ELIGIBLE?



Must be income eligble



Homeowners, renters, and landlords whose current residence/property predates 1978



Have a child under six living in the home, an expectant mother, or a child visiting for 60 hours annually.



The home must test positive for lead.
